- 1] Minutes approved unanimously. Julia motioned, Ben seconded.
- 2] Parent Satisfaction Survey- there was an extended discussion about the parent satisfaction survey results, especially in comparing results from 13-14 to the current 14-15 results. At the end of the discussion, the following areas were requested more detail in the form of disaggregated results for future goal potential:
 - a) The classroom provides a socially and emotionally secure environment for my child.
 - b) The classroom promotes a general enthusiasm for learning.
 - c) Children are generally respectful of each other in class.
- 3] UIP Goals- discussions of work in Reading, Math and Science were briefly discussed in addition to looking at SAC funding where roughly \$5800 is currently allocated in Science material support and another ~\$5000 is projected to support Safety needs. Jeromy briefly discussed Health/Safety related school needs for flooring that he would like the SAC to consider some or all of their remaining funding to support.
- 4] Agreed to reconvene on March 3rd or 4th at 4 pm, whichever worked best for the group. Topics of discussion will be Alumni Survey and Student Survey.

4:40 Roles and Responsibilities

Discussion of Membership ensued - where Mr. Jeromy Johnson is the acting Principal designee member, Ms. Karen Aschenbrenner is the recently elected Teacher member, Ms. Cecilia Stewart, Mr. Ben Williams, and Ms. Katharine Barnes are the three (3) elected parent members, Mr. David Rootes is the acting PTS member as a rep. of MEF, and recently elected Ms. Dawn Lima will fill the community slot, rounding the seven voting slots of SAC membership.

Discussion of Science and Social Studies CMAS scores ensued - where Science which has been a goal is excellent - and Social Studies is solidly on par with District. PARCC scores will not be available until November so guidance on UIP is coming as well as future direction.

5:00 Current UIP goals and monitoring

Based on Parent Surveys from last January 2015, a discussion of Middle School plans to improve Respect and Communications ensued.

Based on SAC input in prior years, a discussion of "Montessori in the Home" connections ensued - where parent
