- 4:00 Reviewed and approved prior meeting minutes group reviewed 10/27/20 SAC meeting minutes (Renee Osterdock motioned to approve, Craig Blumengold seconded approved unanimously)
- 4:10 Head of Schools (HOS) report on school and finances HOS gave update on school's Covid status; UIP due date moved (by the state) from December 2020 to April 2021
- 4:15 Examined and discussed Universal Improvement Plan (UIP) Goal language for reading group reviewed the following three UIP draft/proposed goals (cut/pasted from HOS 11/6/20 email : 1)
 Implement focused additional supports to WATCH students (25-39th percentile) to move 50% or more of the WATCH students in Kg-3rd grade into the At/Above Proficiency; 2) Implement parent and support staff education to increase effectiveness at supporting Reading with students, monthly. (Maybe notes here struggling readers, disability potentials, dyslexia etc.??); 3) Develop community momentum and focus on engaging in Reading outside of school to help inprovement in Reading outcomes for the school (Need action planning ideas?) Group

discussion ensued:

Goal #1: Agreed that 50% was an appropriate goal number

Goal #2: will be broken into separate action plans (parent vs teacher/support staff)

Goal #3: no changes to language in this goal

4:20 Discussed possible Action planning to support UIP Goal

- Goal #1: Apply and extend existing READ Plan support structure and resources to WATCH students and communicate that structure to parent community; staff will receive increased state reading training and dyslexia-specific training
- Goal #2: discussed teacher/support staff education will include increased professional development for all K-3 and EL educators in "teaching of reading" and identification of reading issues in students; discussed using the existing READ Plan template to break out the components of reading and the describe the interventions
- Goal #3: discussed multiple outreach and community level efforts to increase quality and quantity of reading at home including: sharing resources with community to increase access to reading opportunities (eg., Epic and other online book programs, audiobooks, decodeable books, read alouds); monthly(?) communications to community about the science of learning to reading, how to recognize issues, dyslexia, etc. (parent education); creating a reading mentor/mentee relationship between UpperEl or Middle Schoolers and in individual classes (organized by room parents?); community-wide student book club, reading nights, social media sharing, collaborative reading projects; discussed adding questions to parent survey asking about family's home reading practices; discussed making reading seen as a form of entertainment rather than academic they "get" to read, not "have to" read (students rating books, student marketing of popular books/stories, extending UpperEl creative book report to LowerEl); discussed instilling
- Discussed creating a separate "Reading Support Tree" and additional resources project to give parents guidance on what to do if their child has reading difficulties
